INFO v.27/11/2018 WO

- ⇒ Ostend-Bruges is open 24/7 : night rates do apply from 2200LT>0700LT !
- ⇒ PPR is not required at Ostend (EBOS/OST): unless otherwise stated by NOTAM.
- ⇒ It is advisable to send a "heads up" email to navigation@ost.aero stating: *a/c registration, a/c type, MTOW, point of departure, date of flight, intention (nightstop?), total POB, lead name pilot, a/c owner's name & address.*

Inbound VFR:

Pilots shall report at the mandatory Visual Reporting Points (see AIP, link below), "Ostend Approach" on 120.6 . Filing a Flightplan in/out is mandatory (**EBOS TMA/CTR =controlled airspace, CLASS D**).

Unless otherwise instructed by ATC: expect joining a left hand downwind for RWY26, circuit altitude 1000ft AGL , along the canal. RWY08 will normally be right hand downwind along the canal.

- ➔ **Transponder mode S** is mandatory; unfortunately no exemptions will be anymore granted.

Parking:

General Aviation a/c ≤6T MTOW will be parked on **Apron 3** (most westerly apron) : exceptions only on a case by case permission, granted by Airport Authority. For visiting a/c, the marshaller will pick you up on the taxiway, and guide you to your spot. Helicopters to land on the RWY and Hoover-/groundtaxi to the assigned spot (marshaller will be present).

Due to WIP, **WIFI** temporarily not available. Toilets available in the restaurant 26-08 (intra Schengen) or at security checkpoint (all flights).

Taxi's at Apron 3 available on request (intra-schengen flights)

Departure RWY26 / intersection t/o:

Note: In order to reduce the taxi procedure, ATC may, subject to pilot's acceptance, authorize take-off from one of the intersections below. Pilots unable to accept should advise ATC duly in advance.

(*) Intersection C1 can only be used during HJ by aircraft with a weight of 5700 KG MAX.

Airside transport:

The marshaller will provide a **free shuttle** service between **Apron 3** and the terminal building which is located at Apron 2. At the main terminal, public transport (bus, taxi, restaurant) is available.

Handling:

Handling is not mandatory, but available upon request (through local handler).

Emigration/Immigration formalities:

24/7 available and no prior notice required.

Office is located at main terminal building (Apron 2).

Extra Schengen flights may submit their id data (f.i. GAR forms) directly to the immigration office / Federal Police airport unit: LPAO.oostende@skynet.be, to ease formalities upon arrival/departure.

Fees can be settled at APRON 3 on site, with the marshaller: **cards only** (no cash). At the Navigation Office: cards, as well as cash are accepted.

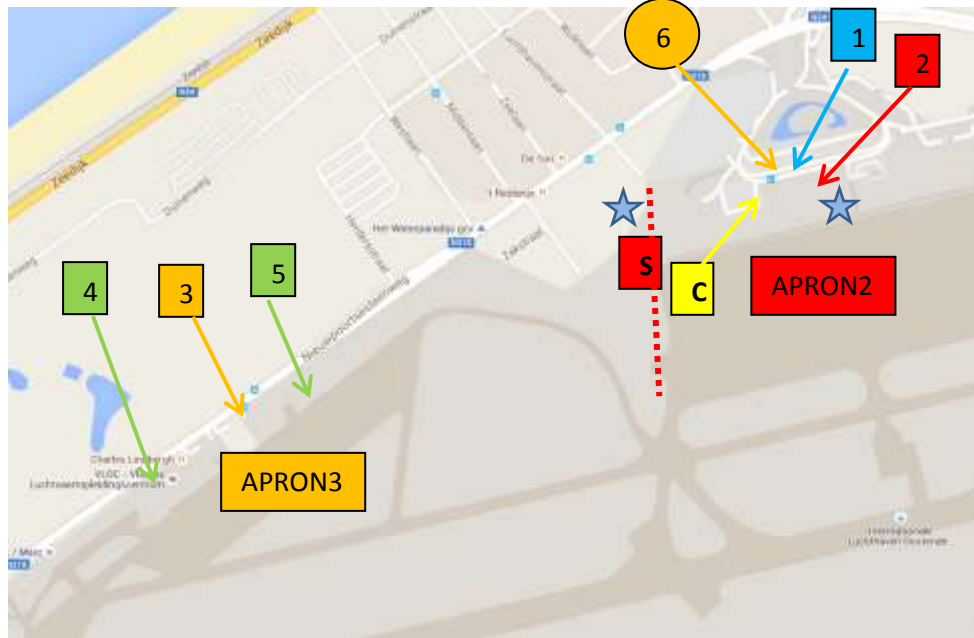

EXIT AIRSIDE / AIRPORT via :

GATE APRON 3 3 : AVAILABLE FOR PILOTS (& ACCOMPANIED PASSENGERS) OF **INTRA-SCHENGEN FLIGHTS** – (security screening exempt) – taxi on request

TERMINAL BUILDING APRON 2 2 : AVAILABLE FOR **ALL** PILOTS (& ACCOMPANIED PASSENGERS) but **MANDATORY** for **EXTRA-SCHENGEN** - SECURITY (screening) CHECK MANDATORY S
 (APRON 2 = SECURED AREA) – customs & immigration available at terminal building. ★ Airside toilet locations.

RE-ENTRY AIRSIDE / AIRPORT via:

GATE APRON 3 3 : ONLY PILOTS & ACCOMPANIED PASSENGERS of **INTRA-SCHENGEN FLIGHTS** (Terminalbuilding is also an option, see below)

TERMINAL BUILDING APRON 2 1 : MANDATORY for all **EXTRA-SCHENGEN FLIGHTS**, available for INTRA-Schengen flights - SECURITY SCREENING MANDATORY AT THIS ENTRY POINT – customs & immigration available & Restaurant “Belair”. Navigation office C : located at airside, apron2 (groundfloor tower)

Clubhouse “Noordzee Vliegclub” (flying club) 4 : landside location, accessible via gate 3 (for extra-schengen flights: after completion of immigration formalities)

Restaurant “Runway 26-08” with terrace 5 : landside location, right next to gate 3. (for extra-schengen flights: after completion of immigration formalities)
